Dostop do informacij javnega značaja

- Zakon je bil sprejet že leta 2003
- Spremembe 2015 onemogočijo zaračunavanje stroškov dela
- Spremembe 2018 onemogočijo zaračunavanje stroškov zaradi stranske udeležbe



Dostop do informacij javnega značaja – v praksi

- Nizka ozaveščenost (potencialnih) prosilcev
- V praksi prihaja do omejevanja pravice na različne načine
- Primer: žičnata ograja

2/2016: Zahteva za dokumente

6/2016: Zavrnilna odločba

10/2016: Informacijski pooblaščenec zahteva razkritje

11/2016: Upravni spor

2/2019: Dokumenti prejeti



Prosilci

- Več kot četrtnina primerov Centra Spregovori! je povezanih z dostopom do informacij javnega značaja
- Težave z nepoznavanjem pravice, neznanje glede pritožb ob molku organa ali zavrnilnih odločbah, strah ob nekaterih taktikah zavezancev
- Malo oz. nič aktivnosti za ozaveščanje prosilcev
